(By MR. MCGRAW)

[Passed March 5, 1974; in effect ninety days from passage.]

AN ACT to amend and reenact section three, article eight, chapter five-a of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to permitting the state agency for surplus property to acquire and distribute surplus property to fire departments, volunteer fire departments and rescue squads.

Be it enacted by the Legislature of West Virginia:

That section three, article eight, chapter five-a of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

ARTICLE 8. STATE AGENCY FOR SURPLUS PROPERTY.

§5A-8-3. Authority and duties of state agency for surplus property.

1 (a) The state agency for surplus property is hereby
2 authorized and empowered (1) to acquire from the
3 United States of America such property, including equip-
4 ment, materials, books or other supplies under the con-
5 trol of any department or agency of the United States
6 of America as may be usable and necessary for edu-
7 cational, fire protection and prevention, rescue, or public
8 health purposes, including research; (2) to warehouse
9 property acquired; and (3) to distribute the property to
10 tax-supported medical institutions, hospitals, clinics, fire
11 departments, rescue squads, health centers, school sys-

12 tems, schools, colleges and universities within the state,
13 and to other nonprofit medical institutions, hospitals,
14 clinics, volunteer fire departments, volunteer rescue
15 squads, health centers, schools, colleges and universities
16 within the state which have been held exempt from tax-
17 ation under section 101 (6) of the United States Internal
18 Revenue Code.

19 (b) For the purpose of executing its authority under
20 this article, the state agency for surplus property is au-
21 thorized and empowered to adopt, amend or rescind rules
22 and regulations as may be deemed necessary, and take
23 other action necessary and suitable in the administration
24 of this article, including the enactment and promulgation
25 of rules and regulations necessary to bring this article and
26 its administration into conformity with any federal stat-
27 utes or rules and regulations promulgated under federal
28 statutes for the acquisition and disposition of surplus
29 property.

30 (c) The state agency for surplus property is author-
31 ized and empowered to appoint advisory boards or com-
32 mittees necessary to the end that this article and the rules
33 and regulations promulgated hereunder conform with
34 federal statutes and rules and regulations promulgated
35 under federal statutes for the acquisition and disposition
36 of surplus property.

37 (d) The state agency for surplus property is author-
38 ized and empowered to take action, make expenditures
39 and enter into contracts, agreements and undertakings
40 for and in the name of the state, require reports, and
41 make investigations as may be required by law or regu-
42 lation of the United States of America in connection with
43 the receipt, warehousing and distribution of property re-
44 ceived by the state agency for surplus property from the
45 United States of America.

46 (e) The state agency for surplus property is authorized
47 and empowered to act as a clearinghouse of information
48 for the public and private nonprofit institutions and agen-
49 cies referred to in subsection (a) of this section, to locate
50 property available for acquisition from the United States
51 of America, to ascertain the terms and conditions under
which the property may be obtained, to receive requests

52 from the above-mentioned institutions and agencies and
53 to transmit to them all available information in reference
54 to the property, and to aid and assist the institutions and
55 agencies in every way possible in the consummation or
56 acquisition of transactions hereunder.

57 (f) The state agency for surplus property, in the ad-
58 ministration of this article, shall cooperate to the fullest
59 extent consistent with the provisions of this article, with
60 the departments or agencies of the United States of
61 America and shall make reports in the form and con-
62 taining the information the United States of America or
63 any of its departments or agencies may from time to time
64 require, and it shall comply with the laws of the United
65 States of America and the rules and regulations of any
66 of the departments or agencies of the United States of
67 America governing the allocation, transfer, use or ac-
68 counting for property donable or donated to the state.
