AN ACT making a supplementary appropriation of public money out of the treasury from the balance of all funds remaining unappropriated from the Revenue Sharing Trust Fund for the fiscal year ending June thirtieth, one thousand nine hundred seventy-seven, to the Department of Natural Resources, Account No. 972, an act, Enrolled Committee Substitute for House Bill No. 701, enacted by the Legislature, regular session, one thousand nine hundred seventy-six, known as the "Budget Bill".

Be it enacted by the Legislature of West Virginia:

That Account No. 972, Enrolled Committee Substitute for House Bill No. 701, an act of the Legislature, one thousand nine hundred seventy-six, known as the Budget Bill, be amended by adding the designated line and be supplemented by adding to the designated line the following sum:
