AN ACT to amend article four, chapter eighteen-a of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section, designated section sixteen, relating to extracurricular assignments for school employees.

Be it enacted by the Legislature of West Virginia:

That article four, chapter eighteen-a of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended year boadding thereto a new section, designated section sixteen, to read as follows:

ARTICLE 4. SALARIES, WAGES, AND OTHER BENEFITS.

§18A-4-16. Extracurricular assignments.

(1) Notwithstanding the provisions of section seven. 1 2 article two of this chapter and section eight, article four of this 3 chapter, the assignment of teachers and auxiliary and service personnel to extracurricular assignments shall be made only 4 by mutual agreement of the employee and the 5 superintendent, or a designated representative, subject to 6 board approval. Extracurricular duties shall mean, but not be 7 8 limited to, any activities that occur at times other than regularly scheduled working hours, which include the 9 instructing, coaching, chaperoning, escorting, providing 10 11 support services or caring for the needs of students, and which occur on a regularly scheduled basis. 12

(2) The employee and the superintendent, or a designated
representative, subject to board approval, shall mutually
agree upon the maximum number of hours of extracurricular
assignment in each school year for each extracurricular
assignment.

(3) The terms and conditions of the agreement betweenthe employee and the board of education shall be in writingand signed by both parties.

21 (4) An employee's contract of employment shall be separate from the extracurricular assignment agreement 22 23provided for in this section and shall not be conditioned upon the employee's acceptance or continuance of any 24 extracurricular assignment proposed by the superintendent, 25a designated representative, or the board: Provided, That if a 26 properly certified replacement for a coach or assistant coach 27 28 of one or more interscholastic athletic teams or a band director satisfactory to the board cannot be employed, the 29 employee under the extracurricular assignment agreement 30 for such duty shall continue that assignment until a properly 31 certified person is employed for the position, but such 32 continued assignment shall not be longer than one year: 33 Provided, however, That dismissal of an interscholastic 34 athletic coach or assistant coach or band director for cause 35 pursuant to section eight, article two of this chapter, under 36 his contract of employment or his extracurricular assignment 37 agreement shall be grounds, at the instance of either party, for 38 termination of the other such contract: Provided, further, 39 That any interscholastic athletic head coach, assistant coach 40 or band director who resigns from his extracurricular 41 42 assignment may at the discretion of the board be placed on the list of transfer and subsequent reassignment pursuant to 43 44 section seven, article two, chapter eighteen-a of this code.
