AN ACT authorizing the county commission of Jefferson County to transfer a certain parcel of real estate located in Middleway District to the Jefferson County Animal Welfare Society, reserving certain reversionary rights.

Be it enacted by the Legislature of West Virginia:

JEFFERSON COUNTY ANIMAL WELFARE SOCIETY.

- §1. Jefferson County commission authorized to transfer a parcel of real estate to the Jefferson County Animal Welfare Society.
 - 1 The Legislature hereby recognizes that the humane detention
 - 2 and disposition of stray and unwanted animals is necessary
 - 3 for the welfare of the people of Jefferson County. Accord-
 - 4 ingly, the Legislature hereby finds and declares that the
 - 5 transfer of land belonging to Jefferson County to any organi-
 - 6 zation or corporation for the furtherance of such activities
 - 7 promotes the general welfare of the public and, therefore, is
 - a public purpose.
 - 9 The county commission of Jefferson County is hereby
 - 10 authorized and empowered to transfer and convey unto the
 - 11 Jefferson County Animal Welfare Society all that certain lot
 - 12 or parcel of land situate in Middleway District of Jefferson
 - 13 County, West Virginia, and more particularly bounded and
 - 14 described as:
 - Beginning at a point in the centerline of West Virginia
 - 16 State Route No. 15, said point being in the western line

17 (extended) of a twenty foot right-of-way; thence with the centerline of said West Virginia State Route No. 15, N 18 19 60 degrees-52'-51"W, a distance of 202.03 feet; thence 20 leaving said centerline, N 19 degrees-49'-53"E, 218.47 feet 21 to a No. 5 rebar; thence S 60 degrees-52'-51"E and parallel to the aforesaid centerline of West Virginia State 22 23 Route No. 15, 202.03 feet to a No. 5 rebar in the westerly 24 line of the aforesaid twenty foot right-of-way; thence with 25 said right-of-way line (extended) S 19 degrees-49'-53"W, 26 218.47 feet to the place of beginning and containing 27 1.00 acres, more or less; and being the same property 28 shown upon a map entitled "Plat of Survey Showing 1.00 29 Acre Parcel, Middleway District, Jefferson County, West 30 Virginia," dated September 5, 1984, and made by Ap-31 palachian Surveys, Inc.; and being a part of the property 32 known as the "Jefferson County Farm" which was con-33 veyed to the County of Jefferson by deed of record in 34 the office of the Clerk of the County Commission of 35 Jefferson County, West Virginia, in Deed Book 38, at 36 page 24, reference to which map and deed is here made 37 for a more particular description of said property.

Any proper conveyance made by the county commission of Jefferson County transferring ownership of the above described parcel to the Jefferson County Animal Welfare Society shall contain a provision that ownership of such property shall revert to the county commission should the land cease to be used for animal shelter purposes.
