

ENROLLED Senate Bill No. 719

(Originating in the Senate Committee on Finance)

[Passed March 8, 1986; in effect from passage.]

AN ACT making a supplementary appropriation of public money out of the treasury from the balance of all general revenue remaining unappropriated for the fiscal year ending June thirtieth, one thousand nine hundred eightyseven, to the West Virginia Library Commission, Account No. 3500, supplementing Enrolled Committee Substitute for House Bill No. 1082, acts of the Legislature, regular session, one thousand nine hundred eighty-six, known as the budget bill.

WHEREAS, The Governor submitted to the Legislature an executive budget document, dated January 8, 1986, wherein is set forth the revenue estimates and financial statements for the general revenue fund, including the fiscal year 1986-87; and

WHEREAS, It appears from such executive budget document that there now remains unappropriated, after enactment of Enrolled Committee Substitute for House Bill No. 1082, the budget bill for fiscal year 1986-87, a balance in the state fund, general revenue, available for further appropriation in respect of fiscal year 1986-87, a part of which balance is hereby appropriated by the terms of this supplementary appropriation bill; therefore,

Be it enacted by the Legislature of West Virginia:

That Account No. 3500, Enrolled Committee Substitute for House Bill No. 1082, acts of the Legislature, regular session, Enr. S. B. No. 719]
