AN ACT to amend and reenact section ten, article two, chapter thirty-one-a of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to reports by financial institutions other than banks; circulation; and publication.

Be it enacted by the Legislature of West Virginia:
That section ten, article two, chapter thirty-one-a of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

## ARTICLE 2. DEPARTMENT OF BANKING.

§31A-2-10. Reports by financial institutions other than banks; circulation; publication.
1 Every financial institution other than banking institu2 tions shall furnish to the commissioner of banking, at
3 least twice each year and within fifteen days after his
4 request therefor, a statement, verified by its president or
5 secretary, and approved by three of its directors, in such
6 form as may be prescribed by the commissioner of bank-
7 ing, showing in detail the actual financial condition and

8 the amount of the assets and liabilities of such financial 9 institution, and shall furnish such other information as to 10 its business and affairs as the commissioner of banking 11 may require, which reports, in the same form in which 12 they are transmitted to the commissioner of banking, shall 13 be printed and circulated among all of the stockholders of 14 the financial institution: Provided, That if such financial 15 institution accepts deposits, or holds public savings in any 16 form or manner, its report shall also be published as a 17 Class I legal advertisement in compliance with the pro18 visions of article three, chapter fifty-nine of this code, and 19 the publication area for such publication shall be the 20 county in which the financial institution is located.
