AN ACT making a supplementary appropriation of public money out of the treasury from the balance of all general revenues remaining unappropriated for the fiscal year ending June thirtieth, one thousand nine hundred eighty-eight, to the Secretary of State, Account No. 2500, supplementing Enrolled Committee Substitute for H. B. 2100, acts of the Legislature, regular session, one thousand nine hundred eighty-seven, known as the budget bill.

~~WHEREAS, The Governor submitted to the Legislature the Executive Budget Document, at regular session, setting forth therein revenue estimates and financial statements and subsequently making revision in the same in respect of the general revenue fund, and the Legislature having finalized and enacted the budget bill for the state for fiscal year 1987-88 therefrom; and~~

~~WHEREAS, The Legislature has enacted at such regular session, Enrolled H. B. 3204 which generated and yielded nine million six hundred thousand dollars of general revenues as a result of the revisions made by such bill to the personal income tax law and as such yield has been furnished pursuant to the estimate of the Governor by Executive Message No. 27 of May 14, 1987 together with the letter of June 5, 1987 of the Governor; a part of which nine million six hundred thousand dollars is hereby appropriated by the terms of this supplementary appropriation bill; therefore~~

Be it enacted by the Legislature of West Virginia:

That Account No. 2500, Enrolled Committee Substitute for H. B. 2100, acts of the Legislature, regular session, one thousand nine hundred eighty-seven, known as the budget bill, be supplemented by adding to such account the following new line item:
