AN ACT making a supplementary appropriation of public money out of the treasury from the balance of all general revenues remaining unappropriated for the fiscal year ending June thirtieth, one thousand nine hundred eighty-eight, to the State Department of Education, Account No. 2860, supplementing chapter one hundred twenty-two, acts of the Legislature, regular session, one thousand nine hundred eighty-seven, known as the budget bill.

Be it enacted by the Legislature of West Virginia:

That Account No. 2860, chapter one hundred twenty-two, acts of the Legislature, regular session, one thousand nine hundred eighty-seven, known as the budget bill, be supplemented by adding the following sum to the designated line item:

1	TITLE 2—APPROPRIATIONS.
2	Section 1. Appropriations from general revenue.
3	EDUCATIONAL
4	30— <i>State Department of Education</i>
5	(WV Code Chapters 18 and 18A)
6	Account No. 2860
7	1 Unclassified \$32,156
8	The purpose of this supplementary appropriation is to

9 supplement this account and the existing line item therein
10 for expenditure in the current fiscal year 1987-88 in order to
11 achieve reimbursement of tuition to any professional
12 teacher renewing his or her professional certificate or other
13 certificates or permits toward maintaining full teaching
14 status and toward completion of requirements and courses
15 for such purpose. The funds hereby appropriated shall be
16 used to pay and reimburse those persons on record with the
17 department as being entitled to payment because the state
18 revenues were insufficient to satisfy the appropriated
19 amounts, notwithstanding that such entitlement to
20 reimbursement accrued in a prior fiscal year. These funds
21 shall be available for expenditure immediately upon the
22 effective date of this bill. Any unexpended balance in the
23 above amount remaining at the close of fiscal year 1987-88
24 is hereby reappropriated for expenditure in fiscal year
25 1988-89.
