[Passed March 7, 1992; in effect ninety days from passage.]

AN ACT to amend and reenact section fourteen, article twelve, chapter eight of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to building permits issued by municipalities; exempting structures and equipment owned by the state, a county or other governmental entity from such permits; and providing an exemption from such permits for certain buildings purchased from the state.

Be it enacted by the Legislature of West Virginia:

That section fourteen, article twelve, chapter eight of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

ARTICLE 12. GENERAL AND SPECIFIC POWERS, DUTIES AND ALLIED RELATIONS OF MUNICIPALITIES, GOVERNING BODIES AND MUNICIPAL OFFICERS AND EMPLOYEES; SUITS AGAINST MUNICIPALITIES.

§8-12-14. Permits for construction and alteration.

1 The governing body of every municipality has

2 plenary power and authority to require a permit as a
3 condition precedent to the erection, construction,
4 repair or alteration of any structure or of any equip-
5 ment or part of a structure which is regulated by state
6 law or municipal ordinance: *Provided*, That no such
7 permits may be required of the state, a county or
8 other governmental entity, its contractors, agents or
9 employees for the erection, construction, repair or
10 alteration of any structure or of any equipment or part
11 of a structure designated for use by the state, a county
12 or other governmental entity.
