AN ACT supplementing, amending, reducing, expiring and transferring between items of the existing appropriation of the department of transportation, division of motor vehicles, Account No. 6710, as appropriated by chapter twelve, acts of the Legislature, regular session, one thousand nine hundred ninety-two, known as the budget bill.

Be it enacted by the Legislature of West Virginia:






