Senate Bill No. 526

(BY SENATOR WIEDEBUSCH)

[Passed April 9, 1993; in effect ninety days from passage.]

AN ACT to amend and reenact section three, chapter two hundred sixteen, acts of the Legislature, regular session, one thousand nine hundred seventy-five, relating to increasing the number of members on the Marshall county activities development authority from seven to nine members.

Be it enacted by the Legislature of West Virginia:

That section three, chapter two hundred sixteen, acts of the Legislature, regular session, one thousand nine hundred seventy-five, be amended and reenacted to read as follows:

§3. Management and control vested in board; appointment and terms of members; vacancies; removal of members; meetings; quorum.

1 The management and control of the authority, its
2 property, operations, business and affairs shall be
3 lodged in a board of nine persons who shall be known
4 as "members of the authority", each of whom shall be
5 appointed for a term of three years, except that as to
6 the first seven appointed to the first board appointed.
7 The terms of two members shall expire on the first
8 day of July next ensuing, the terms of the next two

9 members shall expire on the first day of July two
10 years thereafter, and the terms of three members
11 shall expire on the first day of July three years
12 thereafter: *Provided*, That each of the two additional
13 members shall be appointed for a term that coincides
14 with the terms of the other members of the authority
15 so that the terms of three members shall expire on the
16 first day of July of each year. Each member shall hold
17 office until the expiration of the term for which such
18 member is appointed or until a successor shall have
19 been duly appointed and shall have qualified. Vacan-
20 cies on the board shall be filled by appointment by the
21 county commission for the unexpired term of the
22 member whose office shall be vacant.

23 Each member of the board shall be a citizen of the
24 United States and a resident of Marshall county:
25 *Provided*, That at least two members of the board shall
26 be members of the Marshall county 4-H leader's
27 organization and at least one member of the board
28 shall be a member of a Marshall county home demon-
29 stration club.

30 The county commission may at any time remove
31 any member of the board by an order duly entered of
32 record and may appoint a successor.

33 The board shall elect from its membership a presi-
34 dent and a secretary who shall serve at the will and
35 pleasure of the board. The majority of the board shall
36 constitute a quorum and meetings shall be held at the
37 call of the president or upon request of two members
38 at such time and place as designated in such call or
39 request.
