[Passed March 18, 1994; in effect from passage.]

AN ACT supplementing, amending and transferring between items of the existing appropriation to the crime victims compensation fund, “former” account no. 8412, “WVFIMS” account no. fund 1731, fiscal year 1994, organization 2300, as appropriated by chapter one, acts of the Legislature, first extraordinary session, one thousand nine hundred ninety-three, known as the budget bill.

Be it enacted by the Legislature of West Virginia:

That the items of the total appropriation to “former” account no. 8412, “WVFIMS” account no. fund 1731, fiscal year 1994, organization 2300, chapter one, acts of the Legislature, first extraordinary session, one thousand nine hundred ninety-three, known as the budget bill, be supplemented, amended and transferred thereafter to read as follows:
