ENROLLED Senate Bill No. 158

(By Senators Manchin, Anderson, Grubb and Minard)

[Passed March 10, 1994; in effect from passage.]

AN ACT to amend and reenact section one, article six, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to authorizing the division of corrections to promulgate legislative rules relating to parole supervision.

Be it enacted by the Legislature of West Virginia:

That section one, article six, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

ARTICLE 6. AUTHORIZATION FOR DEPARTMENT OF PUBLIC SAFETY TO PROMULGATE LEGISLATIVE RULES.

§64-6-1. Division of corrections.

- 2 twentieth day of September, one thousand nine hundred
- 3 eighty-eight, modified by the commissioner of the
- 4 department of corrections to meet the objections of the
- 5 legislative rule-making review committee and refiled in
- 6 the state register on the thirteenth day of January, one
- 7 thousand nine hundred eighty-nine, relating to the
- 8 commissioner of the department of corrections (parole
- 9 supervision), are authorized.

- 10 (b) The legislative rules filed in the state register on the twentieth day of September, one thousand nine hundred 11 eighty-eight, modified by the commissioner of the 12 department of corrections to meet the objections of the 13 14 legislative rule-making review committee and refiled in the state register on the thirteenth day of January, one 15 thousand nine hundred eighty-nine, relating to the 16 commissioner of the department of corrections (furlough 17 18 programs for inmates under the custody and control of the commissioner of the department of corrections), are 19 20 authorized.
- 21(c) The legislative rules filed in the state register on the 22sixteenth day of August, one thousand nine hundred ninety-three, modified by the division of corrections to 23 meet the objections of the legislative rule-making review 24 committee and refiled in the state register on the 25 sixteenth day of November, one thousand nine hundred 26 ninety-three, relating to the division of corrections 27(parole supervision), are authorized. 28
