## ENROLLED Senate Bill No. 558

(By Senators Helmick and Whitlow)

[Passed March 8, 1995; in effect from passage.]

AN ACT making a supplementary appropriation of federal funds our of the treasury from the balance of federal moneys remaining unappropriated for the fiscal year ending the thirtieth day of June, one thousand nine hundred ninety-four, to the department of commerce, labor and environmental resources, division of labor, "former" account no. 7884, "WVFIMS" account no. fund 8706, fiscal year 1995, organization 0308, supplementing and amending chapter one, acts of the Legislature, first extraordinary session, one thousand nine hundred ninety-four, known as the budget bill.

Whereas, The governor has established the availability of federal funds for continuing programs now available for expenditure in fiscal year 1994-1995, which are hereby appropriated by the terms of this supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

That the total appropriation to "former" account no. 7884, "WVFIMS" account no. fund 8706, fiscal year 1995, organization 0308, chapter one, acts of the Legislature, first

extraordinary session, one thousand nine hundred ninety-four, known as the budget bill, be supplemented and amended thereafter to read as follows:
