AN ACT to amend and reenact section three, article one, chapter twenty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to continuing the division of natural resources and the parks section of the division of natural resources.

Be it enacted by the Legislature of West Virginia:

That section three, article one, chapter twenty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

- §20-1-3. Division of natural resources, office of director and commission established; termination date for division of natural resources and for parks section of division of natural resources.
 - 1 A division of natural resources, the office of director
 - 2 of the division of natural resources, and a natural resourc-
 - es commission are hereby created and established in the
 state government with jurisdiction, powers, functions, ser
 - vices and enforcement processes as provided in this chap-
 - ter and elsewhere by law.

Pursuant to the provisions of article ten, chapter four of this code, the division of natural resources shall continue to exist until the first day of July, two thousand one.

10 Pursuant to the provisions of article ten, chapter four of this code, the parks section and parks functions of the 11 12 division of natural resources, transferred to the division of natural resources pursuant to the provisions of section 13 14 twelve, article one, chapter five-b of this code, shall continue to exist within the division of natural resources until the 15 first day of July, one thousand nine hundred ninety-six, to 16 allow for monitoring of compliance with recommenda-17 tions contained in the preliminary performance review and 18 19 to allow for further review by the joint committee on gov-20 ernment operations.
