[Passed March 11, 1995; in effect from passage.]

AN ACT to amend article two, chapter twenty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section, designated section fifty-a, relating to licensing wildlife damage control agents; authority of agents; imposition, collection and deposit of fees; and promulgation of rules.

Be it enacted by the Legislature of West Virginia:

That article two, chapter twenty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended by adding thereto a new section, designated section fifty-a, to read as follows:

ARTICLE 2. WILDLIFE RESOURCES.

§20-2-50a. Wildlife damage control agents; licensing.

1 The director may issue a license to a person to act as a
2 wildlife damage control agent. Unless otherwise prohib-
3 ited by law, any person licensed as a wildlife damage
4 control agent, acting pursuant to the license and subject

5 to the rules promulgated by the director, is authorized to
6 take and dispose of wildlife found by the wildlife dam-
7 age control agent to be creating a nuisance in or around
8 homes, businesses and other places where the presence
9 of wildlife may be a nuisance. The director is authorized
10 to impose and collect fees when issuing this license and
11 the fees shall be deposited in the nongame wildlife fund.
12 The director shall promulgate rules, pursuant to article
13 three, chapter twenty-nine-a of this code, governing the
14 issuance and use of the license and setting fees.
