AN ACT to amend article one, chapter fifty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section, designated section six-a, relating to appointment of retired magistrates.

Be it enacted by the Legislature of West Virginia:

That article one, chapter fifty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended by adding thereto a new section, designated section six-a, to read as follows:

ARTICLE 1. MAGISTRATE COURTS.

§50-1-6a. Temporary appointment of retired magistrates.

1 The West Virginia supreme court of appeals is
2 authorized and empowered to create a panel of senior
3 magistrates to consist of, and to utilize the talent and
4 experience of, retired magistrates of this state. The
5 supreme court of appeals shall promulgate rules
6 providing for such senior magistrates to be assigned

7 duties as needed and as feasible toward the objective of
8 reducing caseloads and providing for replacement of
9 magistrates who are unavailable: *Provided*, That
10 reasonable payment shall be made to said senior
11 magistrates on a per diem basis: *Provided, however*,
12 That the per diem and retirement compensation of a
13 senior magistrate shall not exceed the salary of a sitting
14 magistrate and allowances shall also be made for
15 necessary expenses pursuant to the travel regulations of
16 the supreme court of appeals.
