[Passed March 9, 1996; in effect ninety days from passage.]

AN ACT to repeal section one, article nine, chapter sixteen of the code of West Virginia, one thousand nine hundred thirty-one, as amended; to repeal section one, article four, chapter twenty-nine of said code; and to repeal section fifteen, article six, chapter sixty-one of said code, all relating to obsolete provisions of the code of West Virginia, horse trading near fairs or religious meetings; notaries in office on January 1, 1931; power of notaries regarding negotiable instruments; common drinking cups; and penalties.

Be it enacted by the Legislature of West Virginia:

That section one, article nine, chapter sixteen of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be repealed; that section one, article four, chapter twenty-nine of said code be repealed; and that section fifteen, article six, chapter sixty-one be repealed, all to read as follows:

CHAPTER 16.

ARTICLE 9. OFFENSES GENERALLY.

§16-9-1. Common drinking cup prohibited; penalty.

3 amended, is hereby repealed.

CHAPTER 29.

ARTICLE 4. NOTARIES PUBLIC AND COMMISSIONERS.

§29-4-1. Notaries in office on January 1, 1931.

1 Section one, article four, chapter twenty-nine of the
2 code of West Virginia, one thousand nine hundred
3 thirty-one, as amended, is hereby repealed.

CHAPTER 61.

ARTICLE 6. CRIMES AGAINST THE PEACE.

§61-6-15. Horse trading near fairs or religious meetings.

1 Section fifteen, article six, chapter sixty-one of the
2 code of West Virginia, one thousand nine hundred
3 thirty-one, as amended, is hereby repealed.
