

[Passed April 12, 1997; in effect from passage.]

AN ACT supplementing, amending, reducing and transferring an item of the existing appropriation to the department of health and human resources, division of health, central office, account no. 0407, fiscal year 1997, organization 0506, to the department of education and the arts, state board of rehabilitation—division of rehabilitation services, account no. fund 0310, fiscal year 1997, organization 0932, as originally appropriated by chapter eight, acts of the Legislature, regular session, one thousand nine hundred ninety-six, known as the "Budget Bill".

Be it enacted by the Legislature of West Virginia:

That the items of appropriation from the department of health and human resources, division of health, central office, account no. 0407, fiscal year 1997, organization 0506, be amended and reduced in the line item as follows:

The item for revolving loan fund 45 assistance technology, department of health and human resources, division of health, central office, is reduced in 46 47 its entirety by one hundred thousand dollars and 48 transferred to the new item for technology-related 49 assistance revolving loan fund for individuals with 50 disabilities, department of education and the arts, state 51 board of rehabilitation, division of rehabilitation services. 52 The total appropriations to the aforesaid accounts are respectively reduced and increased accordingly. 53 54 amounts as itemized for expenditure in the fiscal year ending the thirtieth day of June, one thousand nine 55 56 hundred ninety-seven, shall be available for expenditure 57 immediately upon the effective date of this bill.
