AN ACT to amend and reenact section one, article eight, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating generally to the promulgation of administrative rules by the various executive or administrative agencies and the procedures relating thereto; legislative mandate or authorization for the promulgation of certain legislative rules by various executive and administrative agencies of the state; authorizing certain of the agencies to promulgate certain legislative rules in the form that the rules were filed in the state register; authorizing certain of the agencies to promulgate legislative rules as amended by the Legislature; authorizing certain of the agencies to promulgate legislative rules with various modifications presented to and recommended by the legislative rule-making review

committee; authorizing the division of motor vehicles to promulgate a legislative rule relating to the motor vehicle inspection manual; and authorizing the division of motor vehicles to promulgate a legislative rule relating to compulsory motor vehicle insurance.

Be it enacted by the Legislature of West Virginia:

That section one, article eight, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

ARTICLE 8. AUTHORIZATION FOR DEPARTMENT OF TRANSPORTATION TO PROMULGATE LEGISLATIVE RULES.

§64-8-1. Division of motor vehicles.

1 (a) The legislative rule filed in the state register on the
2 fifteenth day of August, one thousand nine hundred
3 ninety-six, authorized under the authority of section nine,
4 article two, chapter seventeen-a of this code, modified by
5 the division of motor vehicles to meet the objections of the
6 legislative rule-making review committee and refiled in
7 the state register on the twenty-fourth day of October, one
8 thousand nine hundred ninety-six, relating to the division
9 of motor vehicles (motor vehicle inspection manual, 91
10 CSR 12), is authorized.

11 (b) The legislative rule filed in the state register on the
12 twenty-second day of August, one thousand nine hundred
13 ninety-six, authorized under the authority of section nine,
14 article two, chapter seventeen-a of this code, modified by
15 the division of motor vehicles to meet the objections of the
16 legislative rule-making review committee and refiled in
17 the state register on the twenty-eighth day of October, one
18 thousand nine hundred ninety-six, relating to the division
19 of motor vehicles (compulsory motor vehicle insurance, 91
20 CSR 13), is authorized.
