AN ACT to amend and reenact section five, article one-a, chapter twenty-nine of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to continuation of the commission on uniform state laws.

Be it enacted by the Legislature of West Virginia:

That section five, article one-a, chapter twenty-nine of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended an reenacted to read as follows:

ARTICLE 1A. COMMISSION ON UNIFORM STATE LAWS.

§29-1A-5. Reestablishment of commission.

1 After having conducted a preliminary performance
2 review through its joint committee on government opera-
3 tions, pursuant to article ten, chapter four of this code, the
4 Legislature hereby finds and declares that the commission
5 on uniform state laws should be continued and reestab-
6 lished. Accordingly, notwithstanding the provisions of
7 article ten, chapter four of this code, the commission on
8 uniform state laws shall continue to exist until the first
9 day of July, two thousand four.
