Senate Bill No. 399

(BY SENATORS WOOTON, BALL, BOWMAN, DITTMAR, HUNTER, KESSLER, OLIVERIO, SCHOONOVER, SNYDER AND WHITE)

[Passed March 12, 1998; to take effect July 1, 1998.]

AN ACT to amend chapter twelve of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new article, designated article four-a, relating to establishing an office for the receipt and referral of reports of suspected fraud, misappropriation, mismanagement or waste of state funds for the state of West Virginia; authorizing employment of a staff; procedures; and confidentiality.

Be it enacted by the Legislature of West Virginia:

That chapter twelve of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended by adding thereto a new article, designated article four-a, to read as follows: Enr. S. B. No. 399]

ARTICLE 4A. CENTRALIZED MANAGEMENT OF COMPLAINTS.

§12-4A-1. Legislative findings.

1 The Legislature finds that there is no centralized state 2 authority responsible for receiving and referring reports 3 of possible fraud, misappropriation of, mismanagement or 4 waste of state funds. It is the intent of the Legislature to see that all state funds are utilized for the maximum 5 benefit of the people of the state of West Virginia. The 6 7 Legislature finds that it is important to provide the people 8 of this state with both a forum and an opportunity to report suspected fraud, waste or abuse of state funds, and 9 to have those reports properly investigated. 10

§12-4A-2. General purpose.

1 The state auditor shall have authority to receive reports 2 of possible fraud, misappropriation, mismanagement or 3 waste of state funds of the state of West Virginia and to 4 refer such reports to the commission on special investiga-5 tions, county prosecutors and law-enforcement agencies. §12-4A-3. Duties generally.

(a) The state auditor may employ a forensic accountant
to receive and review reports of suspected fraud, misappropriation, mismanagement or waste of state funds
which shall be filed in that office. Such reports shall be
confidential, except that the state auditor or his or her
designee may supply information necessary to effectuate
this article to the appropriate governmental entities.

8 (b) The state auditor shall establish modes of communi-9 cation sufficient to receive reports of suspected fraud, 10 misappropriation of, mismanagement or waste of state 11 funds. Reports of suspected fraud, misappropriation, 12 mismanagement or waste may be filed by any citizen or 13 employee of the state of West Virginia.

(c) Nothing in this article shall be construed to limit theauthority of any other governmental entity to conduct an

16 internal investigation of suspected fraud, misappropria-

17 tion, mismanagement or waste.

§12-4A-4. Enforcement.

1 (a) The authority to enforce the provisions of this article 2 shall be vested in the state auditor. The state auditor shall 3 promptly forward any evidence of suspected fraud, 4 misappropriation of, mismanagement or waste of state 5 funds to the commission on special investigations and, if potentially criminal in nature, to the prosecuting attorney 6 of the county in which such is alleged to have taken place, 7 8 to the law-enforcement agency with jurisdiction in the area as well as to the commission on special investiga-9 10 tions.

(b) If such reports are made about an agency that has its
own investigative body, then the state auditor may refer
evidence of the fraud, misappropriation, mismanagement
or waste to that investigative body.
