Senate Bill No. 734

(BY SENATOR PLYMALE)

[Passed March 12, 1998; in effect ninety days from passage.]

AN ACT to amend and reenact section two, article six, chapter twelve of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to redefining the consolidated pension plan to include the wildlife endowment fund.

Be it enacted by the Legislature of West Virginia:

That section two, article six, chapter twelve of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

ARTICLE 6. WEST VIRGINIA STATE BOARD OF INVESTMENTS. \$12-6-2. Definitions.

- 1 As used in this article unless a different meaning clearly
- 2 appears from the context:
- 3 (1) "Beneficiaries" means those individuals entitled to 4 benefits from the consolidated pension plan;
- 5 (2) "Board" means the governing body for the West
- 6 Virginia investment management board, and any reference
- 7 elsewhere in this code to board of investments or West
- 8 Virginia trust fund means the board as defined herein;
- 9 (3) "Consolidated fund" means the investment fund
- 10 managed by the board and established pursuant to
- 11 subsection (a), section eight of this article;
- 12 (4) "Consolidated pension plan" means the public
- 13 employees retirement system established in article ten,
- 14 chapter five of this code, the teachers retirement system
- 15 established in article seven-a, chapter eighteen of this
- 16 code, the West Virginia state police retirement system
- 17 established in article two-a, chapter fifteen of this code,
- 18 the death, disability and retirement fund of the state
- 19 police established in article two, chapter fifteen of this
- 20 code, the judges' retirement system established in article
- 21 nine, chapter fifty-one of this code, the workers' compen-
- 22 sation fund established in article three, chapter twenty-
- 23 three of this code, the wildlife endowment fund estab-
- 24 lished in article two-b, chapter twenty of this code, and
- 25 the coal-workers' pneumoconiosis plan established in
- 26 article four-b, chapter twenty-three of this code;
- 27 (5) "Local government funds" means the moneys of a
- 28 political subdivision, including policemen's pension and
- 29 relief funds, firemen's pension and relief funds and
- 30 volunteer fire departments, transferred to the board for
- 31 deposit;
- 32 (6) "Participant plan" means any component system,
- 33 plan or fund of the consolidated pension plan within the
- 34 definition set forth in subdivision (4) of this section;

- 35 (7) "Political subdivision" means and includes a county,
- 36 municipality or any agency, authority, board, county
- 37 board of education, commission or instrumentality of a
- 38 county or municipality and regional councils created
- 39 pursuant to the provisions of section five, article twenty-
- 40 five, chapter eight of this code;
- 41 (8) "Trustee" means any member serving on the West
- 42 Virginia investment management board: Provided, That
- 43 in section nine-a of this article wherein the terms of the
- 44 trust indenture are set forth, "trustee" means the West
- 45 Virginia investment management board;
- 46 (9) "Securities" means all bonds, notes, debentures or
- 47 other evidences of indebtedness, and other lawful invest-
- 48 ment instruments; and
- 49 (10) "State funds" means all moneys of the state which
- 50 may be lawfully invested except the "school fund" estab-
- 51 lished by section four, article XII of the state constitution.
