[Passed March 14, 1998; in effect from passage.]

AN ACT supplementing, amending, reducing and transferring between items of the existing appropriations to the public service commission, account no. fund 8623, fiscal year 1998, organization 0926, as originally appropriated by chapter five, acts of the Legislature, first regular session, one thousand nine hundred ninety-seven, known as the budget bill.

Be it enacted by the Legislature of West Virginia:

That the items of the total appropriation to the public service commission-motor carrier division, account no. fund 8623, fiscal year 1998, organization 0926, be amended and reduced in the line item as follows:
