[Passed February 17, 1998; in effect ninety days from passage.]

AN ACT to amend and reenact section three, article one, chapter twenty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to continuing the parks section and the parks functions of the division of natural resources.

Be it enacted by the Legislature of West Virginia:

That section three, article one, chapter twenty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

ARTICLE 1. ORGANIZATION AND ADMINISTRATION.

§20-1-3. Division of natural resources, office of director and commission established; termination date for division of natural resources and for parks section of division of natural resources.

1 A division of natural resources, the office of director of
2 the division of natural resources and a natural resources
3 commission are hereby created and established in the state
4 government with jurisdiction, powers, functions, services
5 and enforcement processes as provided in this chapter and
6 elsewhere by law.

7 Pursuant to the provisions of article ten, chapter four of
8 this code, the division of natural resources shall continue
9 to exist until the first day of July, two thousand one.

10 Pursuant to the provisions of article ten, chapter four of
11 this code, the parks section and parks functions of the
12 division of natural resources, transferred to the division of
13 natural resources pursuant to the provisions of section
14 twelve, article one, chapter five-b of this code, shall
15 continue to exist within the division of natural resources
16 until the first day of July, one thousand nine hundred
17 ninety-nine.
