Senate Bill No. 2002

(By Senators Tomblin, Mr. President, and Sprouse, By Request of the Executive)

[Passed May 20, 1999; in effect from passage.]

AN ACT supplementing, amending, reducing and increasing items of the existing appropriations from the state fund, general revenue, to the department of military affairs and public safety—division of corrections—correctional units, fund 0450, fiscal year 1999, organization 0608, as originally appropriated by chapter six, acts of the Legislature, regular session, one thousand nine hundred ninety-eight, known as the "budget bill".

Be it enacted by the Legislature of West Virginia:

That the items of the total appropriations from the state fund, general revenue, to the department of military affairs and public safety—division of corrections—correctional units, fund 0450, fiscal year 1999, organization 0608, be amended and reduced in the line items as follows:

35 The purpose of this supplementary appropriation bill is 36 to supplement, amend, reduce and increase items of 37 existing appropriations in the aforesaid account for the designated spending unit. The line item for personal 38 services (activity 001) is reduced by five hundred thousand 39 40 dollars. The line item for employee benefits (activity 010) is reduced by three hundred seventy-five thousand dollars. 41 The line item for St. Marys Correctional Center (activity 42 43 839) is reduced by five hundred fifty-five thousand dollars. 44 The line item for the Denmar Facility (activity 448) is 45 increased by two hundred twenty thousand dollars. The line item for Mt. Olive Correctional Complex (activity 533) 46 is increased by one million two hundred ten thousand 47 48 dollars. The amounts as itemized for expenditure in the fiscal year ending the thirtieth day of June, one thousand 49 50 nine hundred ninety-nine, shall be available for expendi-51 ture immediately upon the effective date of this bill.
