

AN ACT to amend and reenact article nine, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating generally to the promulgation of administrative rules by the various executive or administrative agencies and the procedures relating thereto; legislative mandate or authorization for the promulgation of certain legislative rules by various executive and administrative agencies of the state; authorizing certain of the agencies to promulgate certain legislative rules in the form that the rules were filed in the state register; authorizing certain of the agencies to promulgate legislative rules as amended by the Legislature; authorizing certain of the agencies to promulgate legislative rules with various modifications presented to

promulgate a legislative rule relating to tutorial education requirements; authorizing the board of acupuncture to promulgate a legislative rule relating to the formation and approval of professional limited liability companies; authorizing the board of chiropractic examiners to promulgate a legislative rule relating to regulation of the board; authorizing the board of chiropractic examiners to promulgate a legislative rule relating to the formation and approval of professional limited liability companies; authorizing the contractor licensing board to promulgate a legislative rule relating to the West Virginia contractor licensing act: authorizing the board of dieticians to promulgate a legislative rule relating to a code of professional ethics, continuing education and examination, licensure and renewal requirements: authorizing the massage therapy licensure board to promulgate a legislative rule relating to massage therapy licensure; authorizing the board of medicine to promulgate a legislative rule relating to licensing, disciplinary and complaint procedures, continuing education and physician assistants; authorizing the board of osteopathy to promulgate a legislative rule relating to the formation and approval of professional limited liability companies; authorizing the board of osteopathy to promulgate a legislative rule relating to fees for services rendered by the board; authorizing the board of pharmacy to promulgate a legislative rule relating to the board; authorizing the board of accountancy to promulgate a legislative rule relating to the board and rules of professional conduct; authorizing the board of barbers and cosmetologists to promulgate a legislative rule relating to procedures, criteria and curricula for examination and licensure of barbers, cosmetologists, manicurists and aestheticians; authorizing the board of barbers and cosmetologists to promulgate a legislative rule relating to a schedule of fines; authorizing the family protection services board to promulgate a legislative rule relating to the licensure of domestic violence perpetrator intervention programs; authorizing the board of examiners in counseling to promulgate a legislative rule relating to licensing; authorizing the board of veterinary medicine to promulgate a legislative rule relating to certified euthanasia technicians; authorizing the board of veterinary medicine to promulgate a legislative rule relating to a schedule of fees; authorizing the office of the

treasurer to promulgate a legislative rule relating to the enforcement of the uniform unclaimed property act; and authorizing the West Virginia infrastructure and jobs development council to promulgate a legislative rule relating to the infrastructure and jobs development council funding rules.

Be it enacted by the Legislature of West Virginia:

That article nine, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:
