[Passed March 11, 1999; in effect from passage.]

AN ACT to amend and reenact section one, article four, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to the promulgation of administrative rules by the various executive or administrative agencies and the procedures relating thereto; legislative mandate or authorization for the promulgation of certain legislative rules by various executive and administrative agencies of the state; authorizing certain agencies to promulgate certain legislative rules in the form that the rules were filed in the state register; authorizing certain agencies to promulgate legislative rules as amended by the Legislature; authorizing certain agencies to promulgate legislative rules with various modifications presented to and recom-

mended by the legislative rule-making review committee; authorizing the department of education and the arts, division of culture and history to promulgate a legislative rule relating to the certified local government program; and authorizing the department of education and the arts, division of culture and history to promulgate a legislative rule relating to standards and procedures for administering state historic preservation programs.

Be it enacted by the Legislature of West Virginia:

That section one, article four, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted, to read as follows:

ARTICLE 4. AUTHORIZATION FOR DEPARTMENT OF EDUCATION AND THE ARTS TO PROMULGATE LEGISLATIVE RULES.

§64-4-1. Division of culture and history.

(a) The legislative rule filed in the state register on the 1 2 twenty-eighth day of October, one thousand nine hundred 3 ninety-seven, under the authority of section eight-d, 4 article one, chapter twenty-nine of this code, modified by 5 the division of culture and history to meet the objections 6 of the legislative rule-making review committee and refiled in the state register on the eighteenth day of 7 December, one thousand nine hundred ninety-eight, 8 9 relating to the division of culture and history (certified local government program, 82 CSR 1), is authorized. 10

11 (b) The legislative rule filed in the state register on the 12 twenty-eighth day of October, one thousand nine hundred ninety-seven, under the authority of section eight-d, 13 article one, chapter twenty-nine of this code, modified by 14 15 the division of culture and history to meet the objections of the legislative rule-making review committee and 16 refiled in the state register on the eighteenth day of 17 December, one thousand nine hundred ninety-eight, 18 relating to the division of culture and history (standards 19 and procedures for administering state historic preserva-20 tion programs, 82 CSR 2), is authorized. 21
