### Senate Bill No. 391

(SENATOR JACKSON, *original sponsor*)

[Passed March 13, 1999; in effect ninety days from passage.]

AN ACT to amend and reenact section eighteen, article four, chapter eighteen-a of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to requiring that all department of education employees receive at least the same pay as employees of the board of education wherein the principal place of employment is located.

*Be it enacted by the Legislature of West Virginia:*

That section eighteen, article four, chapter eighteen-a of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

**ARTICLE 4. SALARIES, WAGES AND OTHER BENEFITS.**

**§18A-4-18. Department of education certified staff salaries.**

1 (a) Personnel employed by the state department of  
2 education who are required to hold a teaching certificate  
3 shall receive a salary that is at least equal to the salary  
4 paid to comparable professional personnel employed by  
5 the county board in the county in which their office is  
6 located, minus the six hundred dollars authorized pursu-  
7 ant to section two of this article for classroom teachers  
8 with twenty years of experience.

9 (b) Effective the first day of July, two thousand two,  
10 service personnel employed by the department of educa-  
11 tion shall receive a salary that is at least equal to the  
12 salary paid to comparable personnel employed by the  
13 county board in the county in which their principal place  
14 of employment is located. The department of education  
15 shall establish a salary schedule that phases in the neces-  
16 sary salary increases before the first day of July, two  
17 thousand two.
