

Senate Bill No. 683

(By Senators Craigo, Anderson, Bailey, Bowman, Chafin, Edgell, Helmick, Jackson, Love, Plymale, Prezioso, Sharpe, Unger, Walker, Sprouse, Boley and Minear)

[Passed March 8, 1999; in effect from passage.]

AN ACT expiring funds to the unappropriated balance in the state fund, general revenue, for the fiscal year ending the thirtieth day of June, two thousand, in the amount of two million one hundred fifty nine thousand dollars from the board of risk and insurance management - premium tax savings fund, fund 2367, fiscal year 2000, organization 0218.

WHEREAS, The Legislature finds that the account balance in the board of risk and insurance management - premium tax savings fund, fund 2367, fiscal year 2000, organization 0218, will exceed that which is necessary for the purposes for which the account was established; therefore

Be it enacted by the Legislature of West Virginia:

- 1 That the balance of funds available for expenditure in
- 2 the fiscal year ending the thirtieth day of June, two
- 3 thousand, to the board of risk and insurance management
- 4 premium tax savings fund, fund 2367, fiscal year 2000,
- 5 organization 0218, be decreased by expiring the amount of
- 6 two million one hundred fifty nine thousand dollars to the

- 7 unappropriated balance of the state fund, general revenue,
- 8 to be available for appropriation during the fiscal year two
- 9 thousand.
- 10 The purpose of this bill is to expire the sum of two
- 11 million one hundred fifty nine thousand dollars from the
- 12 board of risk and insurance management premium tax
- 13 savings fund, fund 2367, fiscal year 2000, organization
- 14 0218, to the unappropriated balance in the state fund,
- 15 general revenue, for the fiscal year ending the thirtieth day
- 16 of June, two thousand, to be available for appropriation
- 17 during the fiscal year two thousand.
