[Passed March 5, 1999; in effect from passage.]

AN ACT expiring funds to the unappropriated balance in the state fund, general revenue, for the fiscal year ending the thirtieth day of June, two thousand, in the amount of one million five hundred thousand dollars from the insurance commission - insurance commission fund, fund 7152, fiscal year 2000, organization 0704.

WHEREAS, The Legislature finds that the account balance in the insurance commission - insurance commission fund, fund 7152, fiscal year 2000, organization 0704, will exceed that which is necessary for the purposes for which the account was established; therefore

*Be it enacted by the Legislature of West Virginia:*

- 1 That the balance of funds available for expenditure in
- 2 the fiscal year ending the thirtieth day of June, two

3 thousand, to the insurance commission - insurance com-  
4 mission fund, fund 7152, fiscal year 2000, organization  
5 0704, be decreased by expiring the amount of one million  
6 five hundred thousand dollars to the unappropriated  
7 balance of the state fund, general revenue, to be available  
8 for appropriation during the fiscal year two thousand.

9 The purpose of this bill is to expire the sum of one  
10 million five hundred thousand dollars from the insurance  
11 commission - insurance commission fund, fund 7152, fiscal  
12 year 2000, organization 0704, to the unappropriated  
13 balance in the state fund, general revenue, for the fiscal  
14 year ending the thirtieth day of June, two thousand, to be  
15 available for appropriation during the fiscal year two  
16 thousand.
