EDGELL, HELMICK, JACKSON, LOVE, PLYMALE, PREZIOSO,
SHARPE, UNGER, WALKER, SPROUSE, BOLEY AND MINEAR)

[Passed March 5, 1999; in effect from passage.]

AN ACT expiring funds to the unappropriated balance in the state fund, general revenue, for the fiscal year ending the thirtieth day of June, two thousand, in the amount of two million dollars from the public service commission, fund 8623, fiscal year 2000, organization 0926.

WHEREAS, The Legislature finds that the account balance in the public service commission, fund 8623, fiscal year 2000, organization 0926, will exceed that which is necessary for the purposes for which the account was established; therefore

Be it enacted by the Legislature of West Virginia:

- 1 That the balance of funds available for expenditure in
- 2 the fiscal year ending the thirtieth day of June, two
- 3 thousand, to the public service commission, fund 8623,
- 4 fiscal year 2000, organization 0926, be decreased by

5 expiring the amount of two million dollars to the unappro-
6 priated balance of the state fund, general revenue, to be
7 available for appropriation during the fiscal year two
8 thousand.

9 The purpose of this bill is to expire the sum of two
10 million dollars from the public service commission, fund
11 8623, fiscal year 2000, organization 0926, to the unappro-
12 priated balance in the state fund, general revenue, for the
13 fiscal year ending the thirtieth day of June, two thousand,
14 to be available for appropriation during the fiscal year two
15 thousand.
