[Passed November 14, 2000; in effect from passage.]

AN ACT supplementing, amending, reducing and increasing between items of the existing appropriations from the state fund, general revenue, governor's office, civil contingent fund, fund 0105, fiscal year 2001, organization 0100, and legislative, joint expenses, fund 0175, fiscal year 2001, organization 2300, as originally appropriated by chapter ten, acts of the Legislature, first regular session, two thousand, known as the "Budget Bill," and decreasing the sum of two million dollars from governor's office, civil contingent fund, fund 0105, fiscal year 2001, organization 0100, and making a supplemental appropriation in the amount of two million dollars to the legislative, joint expenses, fund 0175, fiscal year 2001, organization 2300.

Be it enacted by the Legislature of West Virginia:

That the amount of two million dollars be decreased from governor's office, civil contingent fund, fund 0105, fiscal year 2001, organization 0100 as follows:





25 authorized by this bill shall be completed upon passage of the
26 bill.


