AN ACT expiring funds to the unappropriated balance in the state fund, general revenue, for the fiscal year ending the thirtieth day of June, two thousand three, in the amount of seven hundred fifty thousand dollars from the public service commission, fund 8623, fiscal year 2003, organization 0926.

WHEREAS, The Legislature finds that the account balance in the public service commission, fund 8623, fiscal year 2003, organization 0926, will exceed that which is necessary for the purposes for which the account was established; therefore

*Be it enacted by the Legislature of West Virginia:*

- 1 That the balance of the funds available for expenditure
- 2 in the fiscal year ending the thirtieth day of June, two
- 3 thousand three, to the public service commission, fund
- 4 8623, fiscal year 2003, organization 0926, be decreased by

5 expiring the amount of seven hundred fifty thousand  
6 dollars to the unappropriated balance of the state fund,  
7 general revenue, to be available for appropriation during  
8 fiscal year two thousand three.

9 The purpose of this bill is to expire the sum of seven  
10 hundred fifty thousand dollars from the public service  
11 commission, fund 8623, fiscal year 2003, organization  
12 0926, to the unappropriated balance in the state fund,  
13 general revenue, for the fiscal year ending the thirtieth day  
14 of June, two thousand three, to be available for appropria-  
15 tion during fiscal year two thousand three.
