Senate Bill No. 1004

(BY SENATOR HELMICK)

[Passed March 21, 2004; in effect from passage.]

AN ACT making a supplementary appropriation from the balance of moneys remaining unappropriated for the fiscal year ending June 30, 2004, to the public service commission, fund 8623, fiscal year 2004, organization 0926, all supplementing and amending the appropriation for the fiscal year ending June 30, 2004.

WHEREAS, The Governor has established that there now remains an unappropriated balance in the public service commission, fund 8623, fiscal year 2004, organization 0926, available for expenditure during the fiscal year ending June 30, 2004; therefore

Be it enacted by the Legislature of West Virginia:

That the total appropriation for the fiscal year ending June 30, 2004, to fund 8623, fiscal year 2004, organization 0926, be supplemented and amended by increasing the total appropriation as follows:
