AN ACT to amend and reenact §15-2-25 of the code of West Virginia, 1931, as amended, relating to permitting a retired member of the state police to carry a concealed weapon for the life of the member.

*Be it enacted by the Legislature of West Virginia:*

That §15-2-25 of the code of West Virginia, 1931, as amended, be amended and reenacted to read as follows:

**ARTICLE 2. WEST VIRGINIA STATE POLICE.**


**§15-2-25. Rules generally; carrying of weapons upon retirement or medical discharge.**

1 Subject to the written approval of the governor and the  
2 provisions of this article, the superintendent may make  
3 and promulgate proper rules for the government, disci-  
4 pline and control of the West Virginia state police and  
5 shall also cause to be established proper rules for the  
6 examinations of all applicants for appointment thereto.  
7 The members of the West Virginia state police shall be  
8 permitted to carry arms and weapons and no license may  
9 be required for the privilege.

10 Upon retirement or medical discharge from the West  
11 Virginia state police and with the written consent of the  
12 superintendent, any retired or medically discharged  
13 member may carry a handgun for the life of the member  
14 following retirement or medical discharge notwithstand-  
15 ing the provisions of article seven, chapter sixty-one of  
16 this code: *Provided*, That the superintendent's written  
17 letter of consent to carry a handgun may not last for more  
18 than five years at a time and a retired or medically dis-  
19 charged member who wishes to continue to carry a hand-  
20 gun beyond five years of the date of his or her initial  
21 retirement or medical discharge must request and obtain  
22 a renewal of the superintendent's written permission to  
23 carry a handgun at least once every five years. A retired  
24 or medically discharged member desiring to carry a  
25 handgun after retirement or medical discharge must  
26 provide his or her own handgun. Upon request, each  
27 member shall be presented with a letter of authorization  
28 signed by the superintendent authorizing the retired or  
29 medically discharged member to carry a handgun. The  
30 written authorization shall be carried by the retired or  
31 medically discharged member at all times that he or she  
32 has a handgun on his or her person. The superintendent  
33 may not issue a letter of authorization to any retired or  
34 medically discharged member who is no longer employed  
35 by the state police due to a mental disability or who the  
36 superintendent has reason to believe is mentally incapaci-  
37 tated to the extent it would present a threat of physical  
38 harm to one or more persons for the member to carry a

39 concealed weapon. The superintendent may revoke the  
40 authority at any time without cause and without recourse.  
41 Conviction of the retired or medically discharged member  
42 for the commission of any felony or for a misdemeanor  
43 involving the improper or illegal use of a firearm shall  
44 cause this authority to terminate immediately without a  
45 hearing or other recourse and without any action on the  
46 part of the superintendent. The superintendent shall  
47 promulgate a legislative rule in accordance with the  
48 provisions of chapter twenty-nine-a of this code, which  
49 rule shall prescribe requirements necessary for the issu-  
50 ance and continuance of the authority herein granted.


