AN ACT to amend and reenact §11-13A-3b of the Code of West Virginia, 1931, as amended, relating to reducing the rate of tax paid on privilege of severing timber after specified date; and deleting obsolete language.

Be it enacted by the Legislature of West Virginia:

That §11-13A-3b of the Code of West Virginia, 1931, as amended, be amended and reenacted to read as follows:

ARTICLE 13A. SEVERANCE AND BUSINESS PRIVILEGE TAX ACT.

§11-13A-3b. Imposition of tax on privilege of severing timber.

- 1 (a) Imposition of tax. For the privilege of engaging or
- 2 continuing within this state in the business of severing
- 3 timber for sale, profit or commercial use, there is hereby
- 4 levied and shall be collected from every person exercising
- 5 such privilege an annual privilege tax.

6 (b) Rate and measure of tax. - The tax imposed in 7 subsection (a) of this section shall be three and twenty-two 8 hundredths percent of the gross value of the timber 9 produced, as shown by the gross proceeds derived from the sale thereof by the producer, except as otherwise provided 10 11 in this article: *Provided*, That as to timber produced after the thirty-first day of December, two thousand six, the 12 rate of the tax imposed in subsection (a) of this section 13 14 shall be one and twenty-two hundredths percent of the 15 gross value of the timber produced, as shown by the gross 16 proceeds derived from the sale thereof by the producer, 17 except as otherwise provided in this article.

18 (c) Tax in addition to other taxes. - The tax imposed by
19 this section shall apply to all persons severing timber in
20 this state and shall be in addition to all other taxes im21 posed by law.
