AN ACT to amend and reenact §51-9-9 of the Code of West Virginia, 1931, as amended, relating to requiring certified copies of eligibility for judicial retirement be provided to the Supreme Court of Appeals and the Consolidated Public Retirement Board; and making stylistic changes throughout.

Be it enacted by the Legislature of West Virginia:

That §51-9-9 of the Code of West Virginia, 1931, as amended, be amended and reenacted to read as follows:

ARTICLE 9. RETIREMENT SYSTEM FOR JUDGES OF COURTS OF RECORD.

§51-9-9. Determination of eligibility for benefits.

1 Before any person is entitled to retirement benefits
2 under the provisions of this article, he or she shall
3 submit proof of his or her eligibility for retirement
4 benefits to the Governor. If the judge is still sitting, he
5 or she shall at the same time tender to the Governor his
6 or her resignation as judge to the Governor upon
7 condition that, if the resignation is accepted, he or she
8 will be paid retirement benefits as provided in this
9 article. Upon request for retirement by a sitting judge,
10 the Governor shall investigate to the extent he or she
11 deems advisable to determine the judge's eligibility. If
12 the Governor determines that such person is entitled to
13 retirement benefits under the provisions of this article,
14 the Governor shall accept the resignation and certify
15 the facts and the amount of retirement benefits to be
16 paid to the judge upon retirement by a written order
17 filed in the office of the Secretary of State. The
18 Secretary of State shall, upon receipt of the order, file
19 a certified copy of the order with the State Auditor, the
20 Governor's office, the Supreme Court of Appeals'
21 administrative office and the Consolidated Public
22 Retirement Board. After accepting the judge's
23 resignation, a vacancy is created in the office of the
24 retiring judge which shall be filled by appointment or
25 election as provided by law.
