AN ACT to amend and reenact §18B-17-2 and §18B-17-3 of the Code of West Virginia, 1931, as amended, all relating to authorizing rules for the Higher Education Policy Commission and the West Virginia Council for Community and Technical College Education regarding the West Virginia Higher Education Grant Program and the Workforce Development Initiative Program.

*Be it enacted by the Legislature of West Virginia:*

That §18B-17-2 and §18B-17-3 of the Code of West Virginia,

1931, as amended, be amended and reenacted, all to read as follows:

**ARTICLE 17. LEGISLATIVE RULES.**

**§18B-17-2. Authorizing rules of Higher Education Policy Commission.**

1 (a) The legislative rule filed in the State Register on  
2 the fifteenth day of October, two thousand four, relating  
3 to the Higher Education Policy Commission  
4 (Underwood-Smith Teacher Scholarship Program rule)  
5 is authorized.

6 (b) The legislative rule filed in the State Register on  
7 the fifteenth day of October, two thousand four, relating  
8 to the Higher Education Policy Commission (West  
9 Virginia Engineering, Science and Technology  
10 Scholarship Program rule) is authorized.

11 (c) The legislative rule filed in the State Register on  
12 the fifteenth day of October, two thousand four, relating  
13 to the Higher Education Policy Commission (Medical  
14 Education Fee and Medical Student Loan Program rule)  
15 is authorized.

16 (d) The legislative rule filed in the State Register on  
17 the twenty-seventh day of October, two thousand five,  
18 relating to the Higher Education Policy Commission  
19 (Authorization of degree-granting institutions) is  
20 authorized.

21 (e) The legislative rule filed in the State Register on  
22 the twenty-third day of August, two thousand six,  
23 relating to the Higher Education Policy Commission  
24 (West Virginia Higher Education Grant Program) is

25 authorized.

**§18B-17-3. Authorizing rule of the Council for Community and  
Technical College Education.**

5 indicators rule) is authorized.

13 to the West Virginia Council for Community and  
14 Technical College Education (Workforce Development  
15 Initiative Program) is authorized.
