AN ACT making a supplementary appropriation of Lottery Net Profits from the balance of moneys remaining as an unappropriated balance in Lottery Net Profits to the Bureau of Senior Services - Lottery Senior Citizens Fund, fund 5405, fiscal year 2008, organization 0508, by supplementing and amending the appropriations for the fiscal year ending the thirtieth day of June, two thousand eight.

WHEREAS, The Governor submitted to the Legislature the Executive Budget Document, dated the ninth day of January, two thousand eight, containing a Statement of the Lottery Net Profits, setting forth therein the cash balance as of the first day

of July, two thousand seven, and further included the estimate of revenues for the fiscal year two thousand eight, less net appropriations; and

WHEREAS, It appears from the Governor's Statement of Lottery Net Profits there now remains an unappropriated balance which is available for appropriation during the fiscal year ending the thirtieth day of June, two thousand eight; therefore

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending  
2 the thirtieth day of June, two thousand eight, to fund  
3 5405, fiscal year 2008, organization 0508, be  
4 supplemented and amended by increasing an existing
