AN ACT making a supplementary appropriation from the balance of moneys remaining unappropriated for the fiscal year ending the thirtieth day of June, two thousand eight, to the Department of Revenue, Office of the Secretary - State Debt Reduction Fund, fund 7007, fiscal year 2008, organization 0701, by supplementing and amending the appropriations for the fiscal year ending the thirtieth day of June, two thousand eight.

WHEREAS, The Governor has established that there remains an unappropriated balance in the Department of Revenue, Office of the Secretary - State Debt Reduction Fund, fund

7007, fiscal year 2008, organization 0701, available for expenditure during the fiscal year ending the thirtieth day of June, two thousand eight, which are hereby appropriated by the terms of this supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending
2 the thirtieth day of June, two thousand eight, to fund

4 supplemented and amended to read as follows:

39 expenditure during the fiscal year two thousand eight.




