[Passed March 8, 2014; in effect from passage.]

AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section, designated §19-21A-4a, relating to administration of West Virginia Conservation Agency programs; providing that elected conservation district supervisors have their applications to participate in West Virginia Conservation Agency programs evaluated and considered by other conservation districts; and requiring the State Conservation Committee to propose rules for legislative approval.

Be it enacted by the Legislature of West Virginia:

That the Code of West Virginia, 1931, as amended, be amended by adding thereto a new section, designated §19-21A-4a, to read as follows:

ARTICLE 21A. CONSERVATION DISTRICTS.

§19-21A-4a. Administration of West Virginia Conservation Agency programs; legislative rules.

1 (a) If an elected conservation district supervisor applies
2 or intends to apply to participate in a West Virginia
3 Conservation Agency program, then all applications for that
4 particular program in that particular district shall be evaluated
5 and approved by a conservation district other than the one
6 being supervised by the elected conservation district
7 supervisor.

8 (b) The State Conservation Committee shall propose rules
9 for legislative approval, pursuant to article three, chapter
10 twenty-nine-a of this code, to establish:

11 (1) The criteria, ranking and standards required for an
12 applicant to qualify to participate in West Virginia
13 Conservation Agency programs;

14 (2) A process to disclose the recipients of the award; and

15 (3) The process for an unsuccessful qualified applicant to
16 appeal an award.
