AN ACT making a supplementary appropriation of federal funds out of the treasury from the balance of federal moneys remaining unappropriated for the fiscal year ending June 30, 2015, to the Department of Environmental Protection, Division of Environmental Protection, fund 8708, fiscal year 2015, organization 0313, by supplementing and amending the appropriations for the fiscal year ending June 30, 2015.

Whereas, The Governor has established the availability of federal funds now available for expenditure in the fiscal year ending June 30, 2015, which are hereby appropriated by the terms of this supplementary appropriation bill; therefore
