1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
2 designated §18-2-16b, relating to transferring the Cedar Lakes Camp and Conference
3 Center from the West Virginia Board of Education to the Department of Agriculture.

Be it enacted by the Legislature of West Virginia:

1 That the Code of West Virginia, 1931, as amended, be amended by adding thereto a new
2 section, designated §18-2-16b, to read as follows:

ARTICLE 2. STATE BOARD OF EDUCATION.

**§18-2-16b. State camp and conference center; property transferred; powers and duties of
Commissioner of Agriculture.**

1 (a) Effective July 1, 2016, the state camp and conference center, known as the Cedar
2 Lakes Camp and Conference Center and its facilities, authorized to be owned and operated by
3 the West Virginia Board of Education under sections sixteen and sixteen-a, article two, chapter
4 eighteen of this code is transferred to the Department of Agriculture. All real and personal property
5 held by the West Virginia Board of Education, including all operating funds for the operations of
6 the camp and conference center, and all employees of the West Virginia Board of Education
7 primarily dedicated to those operations, are transferred to the Department of Agriculture, at their
8 existing hourly rate and with all accrued benefits. All employees shall become will and pleasure
9 employees in accordance with section four, article six, chapter twenty-nine of the code of West
10 Virginia, and are exempt from coverage by classified service. The Commissioner of the
11 Department of Agriculture is given all those powers, duties and responsibilities relating to the state
12 camp and conference center previously vested in the West Virginia Board of Education and its
13 Division of Vocational Education.

14 (b) All active full-time, permanent employees transferred to the Department of Agriculture
15 pursuant to subsection (a) shall participate in the Public Employees Retirement System beginning
16 July 1, 2016. Notwithstanding the provisions of article ten, chapter five of this code, employees
17 transferred pursuant to this section shall be considered a member of the Public Employees

18 Retirement System as of their original date of hire with the Cedar Lake Camp and Conference
19 Center.

20 (c) The Consolidated Public Retirement Board shall transfer assets and service credit from
21 the Teachers Retirement System Trust Fund into the Public Employees Retirement System Trust
22 Fund for those employees who were members in the Teachers Retirement System no later than
23 December 30, 2016. The amount of service credit recognized by the Teachers Retirement System
24 as of June 30, 2016 for the transferring employees shall be the service credit transferred and
25 recognized by the Public Employees Retirement System.

26 The amount of assets to be transferred for each employee who is a member of the
27 Teachers Retirement System shall be computed as of July 1, 2016, using the July 1, 2015,
28 actuarial valuation of the Teachers Retirement System, and updated with seven and one-half
29 percent annual interest to the date of the actual asset transfer. The market value of the assets of
30 the transferring employees in the Teachers Retirement System shall be determined as of the end
31 of the month preceding the actual transfer. To determine the computation of the asset share to
32 be transferred, the Consolidated Public Retirement Board shall:

33 (1) Compute the market value of the Teachers Retirement System assets as of the July
34 1, 2015, actuarial valuation date under the actuarial valuation approved by the Consolidated
35 Public Retirement Board;

36 (2) Compute the actuarial accrued liabilities for all Teachers Retirement System retirees,
37 beneficiaries, disabled retirees and terminated inactive members as of the July 1, 2015, actuarial
38 valuation date;

39 (3) Compute the market value of active member assets in the Teachers Retirement
40 System as of July 1, 2015, by reducing the assets value under subdivision (1) of this subsection
41 by the inactive liabilities under subdivision (2) of this subsection;

42 (4) Compute the actuarial accrued liability for all active Teachers Retirement System
43 members as of the July 1, 2015, actuarial valuation date approved by the Consolidated Public
44 Retirement Board;

45 (5) Compute the funded percentage of the active members' actuarial accrued liabilities
48 under the Teachers Retirement System as of July 1, 2015, by dividing the active members' market
47 value of assets under subdivision (3) of this subsection by the active members' actuarial accrued
48 liabilities under subdivision (4) of this subsection;

49 (6) Compute the actuarial accrued liabilities under the Teachers Retirement System as of
50 July 1, 2015, for active employees transferring to the Public Employees Retirement System; and

51 (7) Determine the assets to be transferred from the Teachers Retirement System to the
52 Public Employees Retirement System by multiplying the active members' funded percentage
53 determined under subdivision (5) of this subsection by the transferring active members' actuarial
54 accrued liabilities under the Teachers Retirement System under subdivision (6) of this subsection
55 and adjusting the asset transfer amount by interest at seven and five-tenths percent for the period
56 from the calculation date of July 1, 2015, through the first day of the month in which the asset
57 transfer is to be completed.

58 (d) Once an employee transfers from the Teachers Retirement System to the Public
59 Employees Retirement System, the Teachers Retirement System shall bar any further liability
60 and the transfer is an agreement whereby the transferring employee forever indemnifies and
61 holds harmless the Teachers Retirement System from providing him or her any form of retirement
62 benefit whatsoever until that employee obtains other employment which would make him or her
63 eligible to reenter the Teachers Retirement System with no credit whatsoever for the amounts
64 transferred to the Public Employees Retirement System.

65 (e) Assets for employees who are members in the Teachers Defined Contribution System
66 pursuant to article seven-b, chapter eighteen, shall remain invested in his or her Teachers Defined
67 Contribution retirement account until termination of employment with the Department of
68 Agriculture.
