1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
2 designated §30-27-15, relating to allowing schools licensed to provide barber,
3 cosmetology and related training to hold theory classes and clinical classes at separate
4 locations; and prohibiting schools licensed to provide barber, cosmetology and related
5 training from being established within the same physical structure as a salon, spa, or
6 similar business.

Be it enacted by the Legislature of West Virginia:

1 That the Code of West Virginia, 1931, as amended, be amended by adding thereto a new
2 section, designated §30-27-15, to read as follows:

ARTICLE 27. BOARD OF BARBERS AND COSMETOLOGISTS.

§30-27-15. Schools may provide certain classes at different locations.

1 A licensed school may provide clinical instruction and theory instruction in separate
2 locations. Any school authorized under this article cannot be established within the same physical
3 structure as a salon, spa or similar business licensed under W. Va. Code §30-27-17.
