1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2017, to
3 the Department of Health and Human Resources, Division of Health - Laboratory Services
4 Fund, fund 5163, fiscal year 2017, organization 0506, the Department of Health and
5 Human Resources, Division of Health – West Virginia Birth-to-Three Fund, fund 5214,
6 fiscal year 2017, organization 0506, and the Department of Health and Human Resources,
7 Division of Human Services – Health Care Provider Tax – Medicaid State Share Fund,
8 fund 5090, fiscal year 2017, organization 0511, by supplementing and amending the
