1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the  
2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2017, to  
3 the Department of Military Affairs and Public Safety, Fire Commission – Fire Marshal Fees,  
4 fund 6152, fiscal year 2017, organization 0619, by supplementing and amending the  
5 appropriations for the fiscal year ending June 30, 2017.

6 Whereas, The Governor has established that there now remains an unappropriated  
7 balance in the Department of Military Affairs and Public Safety, Fire Commission – Fire Marshal  
8 Fees, fund 6152, fiscal year 2017, organization 0619, that is available for expenditure during the  
9 fiscal year ending June 30, 2017, which is hereby appropriated by the terms of this supplementary  
10 appropriation bill; *therefore*

*Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2017, to fund 6152, fiscal  
2 year 2017, organization 0619, be supplemented and amended by increasing existing items of
