1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2017, to the Department of Commerce, Workforce West Virginia – Workforce Investment
4 Act, fund 8749, fiscal year 2017, organization 0323, by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2017.

6 Whereas, The Governor has established the availability of federal funds for expenditure
7 in the fiscal year ending June 30, 2017, which is hereby appropriated by the terms of this
8 supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2017, to fund 8749, fiscal
2 year 2017, organization 0323, be supplemented and amended by increasing an existing item of
3 appropriation as follows:
