1 AN ACT to amend and reenact §55-7-19 of the Code of West Virginia, 1931, as amended, relating
2 to liability for health care providers who provide services at school athletic events;
3 providing that persons licensed, certified or registered in this state or another state to
4 provide health care or professional health care services are subject to limited liability if
5 they render emergency care or treatment at a public or private elementary or secondary
6 school athletic event; outlining circumstances under which liability can be limited;
7 eliminating provisions limiting liability to the extent of insurance coverage; eliminating
8 reference to standard of care in medical professional liability act; and establishing that
9 acts of willful misconduct are not subject to limited liability.

Be it enacted by the Legislature of West Virginia:

1 That §55-7-19 of the Code of West Virginia, 1931, as amended, be amended and
2 reenacted to read as follows:

ARTICLE 7. ACTIONS FOR INJURIES.

**§55-7-19. Liability of health care providers who render services at school athletic events;
limiting liability; exceptions.**

1 (a) Any person licensed by, or certified or registered in, this state or another state to
2 provide health care or professional health care services: (1) Who is in attendance at an athletic
3 event sponsored by a public or private elementary or secondary school; and (2) who gratuitously
4 and in good faith agrees to render emergency care or treatment to any participant during the event
5 in connection with an emergency arising during or as the result of the event, without objection of
6 the participant, may not be held liable for any civil damages as a result of the care or treatment,
7 or as a result of any act or failure to act in providing or arranging further medical treatment.

8 (b) The limitation of liability established by the provisions of this section does not apply to
9 acts or omissions constituting gross negligence or willful misconduct. For purposes of this section,
10 the term "athletic event" includes scheduled practices for any athletic event.






