1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated surplus balance in the State
3 Fund, General Revenue, to the Department of Military Affairs and Public Safety, Adjutant
4 General – State Militia, fund 0433, fiscal year 2018, organization 0603, and to the
5 Department of Military Affairs and Public Safety, Division of Justice and Community
6 Services, fund 0546, fiscal year 2018, organization 0620, by supplementing and amending
7 the appropriations for the fiscal year ending June 30, 2018.

1 WHEREAS, The Governor submitted to the Legislature a Statement of the State Fund,
2 General Revenue, dated May 20, 2018, setting forth therein the cash balance as of July 1, 2017,
3 and further included the estimate of revenues for the fiscal year 2018, less net appropriation
4 balances forwarded and regular appropriations for the fiscal year 2018; and

5 WHEREAS, It appears from the Statement of the State Fund, General Revenue, there
6 now remains an unappropriated surplus balance in the State Treasury which is available for
7 appropriation during the fiscal year ending June 30, 2018; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2018, to fund 0433, fiscal
2 year 2018, organization 0603, be supplemented and amended by increasing an existing item of
3 appropriation as follows:
